



I and my three friends have been regular clients or. Customers at the Cooper Park Tennis Courts and Cafe for eight or nine years on a regular weekly basis. Please do not let this happen. Confirm the contract be once again awarded to the Cooper Park Tennis organisation. Councils should support local community businesses - not be blindsided by large conglomerates.

Along with a wide selection of irate residents, I attended the Council meeting on the 6th November on the subject of the new lease for the tennis courts and cafe.

The meeting resolved to re-issue the tender without the contentious item on multi use.

However, the other subject discussed quite heatedly on that evening was the matter of the choice of tender.

Council at the time was strongly favouring the corporate entity generally known as Voyager.

The word which came up over and over was LOCAL.

I do not need to reiterate the arguments against corporatisation. Council has by now received multiple submissions asking that the chosen tender should be one whose chief preoccupation is to keep the tennis courts and the cafe within the community, run from within and for the community, with the interests and connection, input and participation of the community. Since Councils exist to cater for their constituency, ergo the preferences of the community in matters which affect them should prevail.

By no stretch of the imagination could Voyager be thus defined.

Conglomerates are not local. They do not operate on the personal level. They exist to make money. This involves peripatetic managers, vending machines, standardised operating procedures and nil sense of individual style or input. Rushcutters Bay is the perfect example.

If we want Corporate, Westfield is five minutes away. Nothing less personal or local can be imagined. We appeal to Council - please do not corporatise Cooper Park.

To Mayor Richard Shields and all Woollahra Council Councillors

My husband and I have lived in the Woollahra Council Municipality since our marriage in 1964 and in 1969 moved to Avenue, Woollahra which is on the Edgecliff ridge and not far from Cooper Park Tennis courts. We have four children and now they each have three children, all of whom play or have played tennis. We have both played tennis at Cooper Park, I play on Tuesdays with friends and Saturdays with one of our sons and our three grandchildren, they also play on Sundays. The courts are consistently busy both day and night. Tennis is such a great healthy game going back hundreds of years and can be played by all ages.

Cooper Park Tennis courts were built in 1923 and celebrated 100 years of operation last year, sadly with no fan fare. The courts were originally clay courts for years and have been improved over our years of tennis experience there with the wire fencing between the courts and the sheds built.

We believe Sydney Sports Management Group (SSMG) and Voyager Tennis Academy have been recommended as the preferred tenderer and that this recommendation will be put to a vote at the Council meeting on Tuesday April 2 at 6.30pm. I am very concerned to hear that the Council has recommended the same group SSMG Voyager Operations Pty Ltd as the preferred tenderer as last time as their bid was very contentious and highly rejected by the local tennis community.

In regards to the consideration of Tender Reponses for the Lease and Operation of the Cooper Park Tennis Centre I ask that the Council consider the following before making a final decision.

- 1: Were the Community concerns communicated to and part of the brief to the independent arbitrator or was it just a financial decision.
- 2: That the local communities preference of a local operator was given the appropriate weighting in the overall percentages of the tender.
- 3: The local community made it very clear with over 100 people attending the earlier council meeting, that they wanted it to be a local operator, involved with the community and catering to their specific demographic that included older people.
- 4: That Cooper Park remains a thriving hub and meeting place for the local community.
- 5: Can the councillors make a variance on the process to award the tender to a local person/group.
- 6: Capital works are the capital works proposed expenditure by the parties analysed comparatively. Are the costings on the upgrades to the tennis courts by each party made on the same specifications? Were they similar or was there an inflated variation that impacted on the total amount of capital works proposed by the winning tender.
- 7: I understand that reference were sought, did you know that the Rushcutters Bay tennis courts coffee shop was idle for over a year and is now outsourced.
- 8: Were the small local operators disadvantaged because they don't have as much experience running multiple locations and is this relevant to operating only one location.
- 9: Why did the original tender have a 30% financial component in the evaluation and this tender have a 40% financial component in the evaluation, when it seems the community concerns and input were not given an increase in the percentage of the evaluation.

I feel very disappointed that the Council has not listened to the residents input and feel that the process should be more transparent.


I'm sure we speak on behalf of many who enjoy the current operation, that a change to the nature of the cafe and use of the courts would definitely send us elsewhere.

Thank you for your time. My name is Russell Aboud. I am 66 years old & I have lived in Bellevue Hill for more than 40 years. While not regular, I have played at the Cooper Park courts. I am quite disappointed to hear that our Council has again decided to recommend SSM Voyager to manage this facility. I strongly believe this is not in the interests of local residents. I would like to outline why I think long term this recommendation will lead to a poor outcome. SSM Voyager are a franchise model where the franchisee struggles financially with a consequent effect on our facility. Also they run a cookie cutter approach with no local knowledge, feel or community engagement. We also run a common risk that they bring players from outside our local area (at the expense of locals) to bolster their revenue instead of growing the game locally. The monopoly characteristics of their longer term business plan will mean they have a huge advantage in future tenders that will compromise Woollahra Council's ability to get proper price tension into the process in future tenders. While I am sure you believe this is a good financial outcome for the Council I do not believe you have fully assessed the longer term downside risks both financial & the user utility. I think its only fair that the residents are informed on why you have undertaken this risk on their behalf. Dear Mayor and Councillors,

I am writing in relation to the outcome of the second tender for the management of the Cooper Park tennis courts. Firstly, I would like to express my concern and disappointment that this information was only available just prior to a long weekend, with the meeting immediately following. Clearly this does not provide the many interested parties with the opportunity to be made aware of the outcome, let alone address it. One could surmise that this was intentional?

My main concern about the outcome is that it seems the community sentiment – which came through loud and strong at the last meeting – has had little impact on this process or outcome. We expressed a number of serious concerns, and it's difficult to know to what extent these have been addressed. Although the multisport aspect has been withdrawn from the tender documentation, it seems this would still be possible for the lessees to implement down the track. The term to be 'primarily used' as tennis courts is used, which could be open to interpretation. We have no assurance that this won't happen in the future.

A community engagement criterion formed part of the tender specification. However, awarding the courts to a large organisation which is acquiring courts all over Sydney, does not seem to take into account any true commitment to *this* community. Given the huge amount of support there clearly was for the incumbent lessee, it is baffling that he was not even invited for interview.

We, as the community, have no information about how the new group will run CPT, and whether or not the new lessee will honour the current social groups, which are so important to many, both in and out of the LGA. There is a strong sense amongst Cooper Park supporters, that despite the response at the previous meeting, Council does not care about the community it is supposed to service. This may well be reflected in the next election.

I feel strongly that the future of the courts should have formed part of the overall Cooper Park management plan, and it is difficult not to be cynical about the way in which this outcome has been reached.

As a local resident of the area for over 15 years who has used the centre on numerous occasions, I am writing to express my disappointment to hear that SSM Voyager have been recommended again as the Manager for Cooper Park Tennis Centre.

I understood the process was being re-done due to community concerns about a large corporate coming in to run the centre, the tennis program and the cafe and the lack of a recommendation for a local community-oriented person/small business to run it. I believe that getting a smaller passionate local business to run the centre will provide a better outcome for people locally who use the centre rather than a large corporate entity with no connection to the Eastern Suburbs.

I don't believe the franchise model employed by SSM Voyager will make the centre a great place for excellent tennis coaching, playing and also a community hub with a better food offering in the cafe. It is a well-known fact that local businesses always operate better when the owner is there much of the time, getting to know people and customers and providing the personal touch, and as feedback is given or any issues arise an owner-operator can deal with them directly and not have to channel things up a management line to eventually get a response and act on it and it may not even be a positive response.

I have read of community discontent that the recommendation has gone to SSM Voyager, I can't understand why this choice was made instead of a local operation - is it down to profit for the council? While the money needs to be taken into account as it is ultimately rate-payers money council is managing for us, the benefit to the community and the community opinions and concerns should be taken into account too and I am sure a balance is what the Council would usually try for.

I wish to attend the meeting onTuesday 2 April 2024 at 6:30 pm and to speak on Agenda Item no R 7 at the meeting.

In summary form, I wish to oppose the recommendation to award the lease of the Coooper Park Tennis Courts to the partnership of Sydney Sports Management Group (SSMG) and the Voyager Tennis Academy.

I have been a ratepayer of Woollahra Council for over 30 years and a user of these courts over that period. My objection to the recommendation is on the following basis that:

- (a) such a commercial arrangement conflicts with the proper use of this community facility which has always been designated as part of the approved plan as tennis courts;
- (b) a commercial consortium with its capital proposals for commercialization of the site will inevitably put the facility out of the reach of the community users;
- (c) the prior erroneous lease recommendation contrary to the approved plan and the continued recommendation over he continuing community objections demonstrates that the Council has been committed to this course of action without taking into account the community views. Similarly the very short notification period to affected persons and the holding of the meeting at the conclusion of the Easter holiday period raises an inference that the proposal is being rushed through without sufficient time for community consideration.

Dear All,

I am writing in relation to Woollahra Council's decision to maintain its previous recommendation to award the Cooper Park Tennis Courts lease to the Sydney Sports Management Group (SSMG) and Voyager Tennis Academy.

As Council is very aware, this is an issue that is very important to the local community and we would like Council to listen carefully to what we have to say. I live just above Cooper Park and have been playing tennis at the courts and taking walks through Cooper Park for nearly 60 years. I have witnessed various lessees over the years but it is only since the present lessee Dieter Wilhelmi and his team including Sarah Morante took over that a strong sense of local Cooper Park community feeling has really developed. This community is comprised of tennis players and non-tennis players alike. With their professional, caring and friendly attitude, Dieter and Sarah have earned enormous goodwill, respect and support from everyone in the local area.

The local community reacted strongly against Council's previous recommendation of SSMG and Voyager partnership for a variety of reasons including:

- they are not local and have no knowledge of the community and its interests;
- they already operate a vast number of tennis centres around Sydney and this decision is just further increasing their grip on tennis in the Sydney region concentrating power in the hands of one group;
- they had wanted to convert some courts to multi-sport use that would substantially increase noise levels for the local community and also decrease the number of courts available for hire when they are already heavily booked; and
- the local community stands firmly behind the present lessees who have been doing an outstanding job in serving the local community.

The trend of large corporate groups which come in with higher financial offers, often due to their economies of scale, squeezing out smaller players with strong local roots is very worrying. This should be so much more than just a financial decision. I understand the tender evaluation (which was carried out very quickly) and recommendation of SSMG and Voyager was made by the Finance Committee. I know there were criteria other than money but one may expect finance committees in general to prioritise quantum over other so called 'softer' but very important criteria. After all, these 'softer' criteria are the very areas that most concern the local residents and users.

The local Cooper Park community would like Council to listen to its voice. We elected you to represent us and we feel very strongly about this matter. We do not want the lease of the Cooper Park Tennis Courts to be awarded to a non-local, large corporate group which has no local ties.

We are asking you to please stand up for the local community and do the right thing by us.

I understand that new tenders have now been received and presentations made by the proponents, so in the final stages of evaluation.

I am also lead to believe that 'Voyager' is the preferred tenderer.

I would like to recall the strong views of the tennis community using the courts and facilities, and who by and large are very happy with the incumbent.

So if my understanding is correct, how could Council possibly find 'Voyager' the preferred tenderer, in the interests of the local community, its wishes and relative the local ethos of Cooper Park.

The main issues at the November 6 meeting were . . .

- The successful tenderer should be a local to the area
- Have a strong sense of Community
- Have a strong sense of acceptance from the Community
- A preference for people service over online systems
- A smaller organisation with the personal touch
- No online booking systems
- No multi use courts

While we recognise tenders also include a financial component, we trust Council will not see this as a priority over tenders with smaller or different financial offerings, but more suited to this venue.

Cooper Park is a very special place as we all know. The tennis courts are low key, community based and the tennis fraternity like it pretty much as is.

It is not a big suburban tennis centre, as is the case with Voyager's other venues. Cooper Park tennis courts do not fit into a corporate multi tennis centre culture, bigger is not better, Cooper Park tennis courts are a unique, one off community sports facility.

So we hope Council makes its selection taking into account the above criteria, and the strong sentiment of the meeting of November 6.

That sentiment strongly supported one of the other smaller operators.

We would hope that Woollahra Council does actually listen to its constituents, and not simply select a tenderer on the numbers.

Cooper Park Tennis Courts

I was very supposed to be informed that tomorrow night the Finance, Community and Services (FC&S) Committee will vote on a staff recommendation to accept the tender submitted by SSMG Voyager Operations Pty Ltd for the lease of the Cooper Park Tennis Courts. Surprised for a number of reasons:

1. The agenda appears to have been released late on Easter Monday, 24 hours ahead of the meeting, allowing no real time for anyone to be informed or mount an objection. Why the secrecy and haste? Is the Council unwilling to see open consultation after the opposition to the initial tender process?

2. The Community Consultation on Cooper Park is ongoing and a draft plan has yet to be released, let alone submitted for public consultation. Who's to say a major commercialisation of Cooper Park is in keeping with the desires of the community?

3. The lease agreement is for an initial 7 year plus a 7 year option term. This is unfeasibly long, and egregious if Voyager allows the site to run down, as it has with two of their sites I've visited on the North Shore.

4. We know from the initial tender, Voyager offered the highest fee to the Council, based on its proposal to take tennis courts for use of other faddish sports, including padel. Has the company changed its tender price and/or is it a condition of any contract that the 8 courts remain available to tennis?

5. It seems council is making its decision purely on the highest bid. Is this the best criteria for a loved and well-used public space? Did not other bidders offer better criteria than Voyager than on price?

The undue secrecy and accelerated timing with which this decision appear to be made smells awful. Particularly in the middle of the public consultation on Cooper Park, which now appears to have been merely a ruse to appease the widespread community opposition to the tender process. I do hope the commercial and personal arrangements and connections stand up to governance scrutiny. This continues to be a unclear and questionable process that requires a pause rather than acceleration. Regards, Michael Bodey

Dear Mayor, Councillors, and Manager of Governance & Risk,

I am writing this email as a resident of Cooper Park and a regular tennis player at the Cooper Park Tennis courts and Rushcutters Bay tennis courts and I wish to provide you all with my objections to the consortium of SSMG Voyager Operations Pty Ltd being awarded the successful tenderer.

I have concerns about the matters outlined in the agenda, but more importantly, with councils disregard for the communities' preference for Cooper Park tennis to remain as a unique, personalised recreational facility for locals to socialise and enjoy, as opposed to what I am afraid will become a cold, bottom line financial enterprise that will not provide locals with the meet and greet destination it is today. Nor in my opinion, will it comply with councils "Play Space Strategy", which states that council "Shares the results of community consultation - what's important in the playground to you, and what areas of concern are not being met". As a local resident who lives within 250 meters of the Cooper Park tennis courts, I can advise that the local community does not wish to see a commercial, financial enterprise run the tennis courts. The locals would prefer a more personalised, community - oriented tennis operator that encourages socialisation and community wellbeing.

As councillors will have read, part of SSMG Voyager mission statement states, "we have the ability to commercially maximise valuable community assets" and see "improved profitability". My concern is that SSMG Voyager's Rushcutters Bay tennis courts is an example of the basic, cold attitude that is likely to occur at Cooper Park should they be awarded the tender. IE: No personal involvement; communication or service from management; on line bookings with press button key access to courts; no meet and greet on arrival nor the ability to have planned post tennis social occasions.

In accordance with their website, SSMG states they manage 12 tennis facilities with more in the pipeline. The community of Cooper Park do not wish to endorse a company with a monopolistic business attitude. They wish to maintain this facility as a unique personalised tennis venue within an environment that respects Cooper Park's worth as a historic recreational area. This was the vision in 1885 when Cooper Park was purchased by the then government from the Cooper Park estate.

To Whom It May Concern,

I hope you enjoyed the Easter break.

I understand you are the conduit to Council, so my apologies for what I am suspecting is a strong community voice of protest regarding the imminent decision to appoint a corporate operator to manage Cooper Park Tennis courts.

As a member of a tennis-loving family – both immediate and extended, I represent 17 members of the Woollahra municipality – both O'Neill families (residents of Kambala Rd, March St and Albemarle Ave) and the Miles family ranging in age from 85 to 8 and voting residents for up to 65 years. I have lived here for 50 years.

We have been made aware that Council has decided to recommend Sydney Sports Management Group Voyager Operations (SSMGVO) despite community-wide concerns regarding the transparency of the real benefits to Woollahra residents and the true representation of community sentiment.

The Woollahra municipality has a unique and cherished appeal for its sense of local community, support of local residents' businesses and nurturing of local sporting talent, as well as the provision of true community facilities across the spectrum of ages and genders. The potential decision to appoint a multi-centre operator seems a departure from the Woollahra local community value system. If you drive past the corporate group's operations in Willoughby you are "welcomed" by a website not people. Equally, you see a sea of empty tennis courts — no tennis playing community results in under-utilised community assets. It is a drive I do multiple times a week at multiple times a day. Perhaps the due diligence has been insufficient, due to a lack of available time for Council members?

It is also concerning that the search terms to actually find the SSMGVO tennis courts are complex and not intuitive – a simple search to play tennis on the North Shore will not direct you to this corporate website. You are directed to multiple local tennis clubs and locations – those who understand what recreational tennis players are looking for and how they think. How many opportunities will be lost through an operator without local knowledge and one whose selection of search terms demonstrate cost-minimisation to the operator is the fundamental priority rather than optimising the outcomes for the tennis-playing community.

I appreciate your time and consideration ahead of a final decision.

I am shocked and outraged by Council's decision to recommend SSM Voyager, especially after receiving such strong objection to the corporate commercialisation of the centre at last year's Council meeting. 
I'm writing to express my sincere disappointment to hear of the decision to recommend the Cooper Park tender to SSM Voyager.

I am writing in regard to the proposed leasing arrangements for the Cooper Park Tennis Centre. This correspondence is of necessity "Late Correspondence" as the news of the Committee Meeting to consider a recommendation was only circulated just before Good Friday with the meeting to be held immediately after Easter. Whether this was designed to mute community awareness or merely a rushed process is open to question.

The Council would be well aware of the concern in the community regarding the lease process and I am sure if there was more opportunity for the recommendation to be digested by concerned ratepayers there would be far greater acceptance that the process has been fair and transparent.

The Finance, Community & Services Committee Meeting on November 6<sup>th</sup> last year resolved that:

Staff to consider objective criteria to assess community involvement in the tender to engender a sense of community.

Yet there is nothing in the proposal before Council that illustrates how the proposed tenderer intends to achieve this.

I note that the Council papers refer to "Consultations about the Tender process were undertaken with Council's Open Space and Recreation Planning Team Leader". I am not sure what this refers to as the consultation event at Cooper Park that I attended was in relation to the Plan of Management and explicitly excluded any discussions regarding the tender process. I remain puzzled why Council would embark on a Cooper Park Plan of Management that excludes one of the major features of the park.

The Request for Tender document posted near the tennis courts stated:

The Council will welcome and give favourable consideration to any additional innovative proposal in relation to any capital investment into the fit-out of the Kiosk and/or the operation and maintenance of the Courts including multi-function uses.

The community no doubt would be interested to hear of any "innovative proposals" put forward by the proposed tenderer.

I understand that the reference to "multi-function uses" was amended to make clear that the courts were to be "primarily" used as tennis courts. While this is welcome it does not make clear what "primarily" actually means. I would have thought that it was clear from

the FC&S Committee meeting last year that there was an appetite to make it clear that the tennis courts were intended to be used exclusively for tennis. I am sure the community would be interested in knowing whether the proposed tenderer is still intending to introduce multi-sports.

From discussions with other members of the tennis community it appears there is a great deal of suspicion and concern regarding the re-tender process and that community consultation about what is actually proposed for the site is required.

I would ask the Committee to delay the finalisation of the tender process until some of the issues I and others have raised are taken into account.

I understand the Finance, Community Services Committee will consider the submissions for the new tender for the lease of Cooper Park Tennis Courts at its meeting tomorrow evening. I am not able to attend the meeting so would like to send my views to Councillors in this email.

From viewing the meeting agenda and supporting papers, I read that Council staff have once again recommended that the tender from the joint venture SSMG Voyager Operations Pty Limited be accepted.

First and most importantly, I sincerely thank Councillors for accepting the views of the community of tennis players at Cooper Park and for re-conducting the tender process on the basis that 8 dedicated tennis courts are retained.

Secondly, I remain of the view that Sydney Sports Management Group (SSMG) and Voyager Operations operate their respective tennis centres in a way that it is quite different to the current personal and community nature of Cooper Park. My view is also based on discussions I have had with some highly regarded and knowledgeable people in the tennis community who are familiar with SSMG and Voyager tennis centres. As I said at the Committee meeting last November I hope that Councillors have visited at least some of the

other centres operated by SSMG and by Voyager to see first hand how these tennis centres are run.

I trust that Councillors will be provided in the confidential attachment prepared by Council staff sufficient information to assess how SSMG Voyager Operations will satisfy the new tender criterion "Capacity of the tenderer to engender a sense of community". I hope for example that the successful tenderer will be required to continue to accept telephone and in person bookings and that keypad locks and security cameras will not be installed on the courts at Cooper Park as is done at some other tennis centres.

Because of the Easter holiday and the constrained timeframe within which I could send my original email, dated Saturday, 30 March 2024, at 10:53 PM, I am sending this revised correspondence again along with additional information. Please disregard my previous email and the attached form.

I am writing to you regarding the agenda published on the Woollahra Municipal Council's website for the Finance, Community & Services Committee meeting scheduled for Tuesday, 2 April 2024, at 6:30 pm ("Meeting"). As a dedicated ratepayer and avid tennis enthusiast who frequently utilises the Cooper Park tennis courts, I have concerns about the matters outlined in the agenda, particularly regarding the lease and operation of the Cooper Park tennis courts under tender number SC7818 ("Tender").

The reconsideration of tender SC7193, now the Tender, to the consortium of SSMG Voyager Operations Pty Ltd ("SSMG Voyager"), raises suspicions about the reasons behind this decision, which are not entirely transparent due to the confidentiality surrounding the selection process and public documentation.

Therefore, I encourage the councillors to object the awarding of the Tender to SSMG Voyager and respectfully request the opportunity to attend and speak at the Meeting to address the following concerns:

- Why does the agenda for the Finance, Community & Services Committee meeting scheduled for 6 November 2023, include an attached Report to the Finance, Community & Services Committee dated 3 October 2023, containing detailed information on the bidders and their bids, while the attachments to the Meeting agenda are kept confidential? This departure from standard procedure for a tender already under scrutiny raises serious questions.
- The Recommendation section of the agenda to the Meeting should align with Addendum 1 of the Tender, ensuring that the initial lease period (7 years) and its optional extension period (additional 7 years) explicitly prohibits activities other than tennis on the tennis courts.
- I am sceptical about how SSMG Voyager rationalises paying excessively higher rent of \$290,000 per annum plus GST (compared to \$280,000 in tender SC7193) while maintaining the same exorbitant refurbishment commitment of \$926,408 plus GST, especially

considering the absence of multi-sports in the Tender. It seems improbable that SSMG Voyager would choose to invest significantly more than necessary or more than what other tenderers offer without clear benefits and possibly negative repercussions for the tennis community for years to come.

- 4. Based on shared experiences of tennis enthusiasts regarding the tennis courts managed by SSMG Voyager, there are apprehensions that the ordinary standard provided in these courts may not meet the expectations of the community, possibly falling short of enhancing the distinctive experience already offered by the Cooper Park Tennis Centre for the community.
- 5. I urge the Council to avoid endorsing a monopolistic approach that could disadvantage smaller tennis centre operators and hinder their ability to compete in future tenders against the growing influence of SSMG Voyager. I previously raised these concerns during the Finance, Community & Services Committee meeting on 6 November 2024 and would appreciate the opportunity to reiterate them at the upcoming Meeting.

Thank you for your attention to this matter and respectfully request the opportunity to attend and speak at the Meeting.

I am writing this email as a resident of Cooper Park and a regular tennis player at the Cooper Park Tennis courts and Rushcutters Bay tennis courts and I wish to provide you all with my objections to the consortium of SSMG Voyager Operations Pty Ltd being awarded the successful tenderer.

I have concerns about the matters outlined in the agenda, but more importantly, with councils disregard for the communities' preference for Cooper Park tennis to remain as a unique, personalised recreational facility for locals to socialise and enjoy, as opposed to what I am afraid will become a cold, bottom line financial enterprise that will not provide locals with the meet and greet destination it is today. Nor in my opinion, will it comply with councils "Play Space Strategy", which states that council "Shares the results of community consultation - what's important in the playground to you, and what areas of concern are not being met". As a local resident who lives within 250 meters of the Cooper Park tennis courts, I can advise that the local community does not wish to see a commercial, financial enterprise run the tennis courts. The locals would prefer a more personalised, community - oriented tennis operator that encourages socialisation and community wellbeing.

As councillors will have read, part of SSMG Voyager mission statement states, "we have the ability to commercially maximise valuable community assets" and see "improved profitability". My concern is that SSMG Voyager's Rushcutters Bay tennis courts is an example of the basic, cold attitude that is likely to occur at Cooper Park should they be awarded the tender. IE: No personal involvement; communication or service from

management; on line bookings with press button key access to courts; no meet and greet on arrival nor the ability to have planned post tennis social occasions.

In accordance with their website, SSMG states they manage 12 tennis facilities with more in the pipeline. The community of Cooper Park do not wish to endorse a company with a monopolistic business attitude. They wish to maintain this facility as a unique personalised tennis venue within an environment that respects Cooper Park's worth as a historic recreational area. This was the vision in 1885 when Cooper Park was purchased by the then government from the Cooper Park estate.

I am writing to convey my concerns regarding the recently published agenda on the Woollahra Municipal Council's ("Council") website for the Finance, Community & Services Committee meeting scheduled for Tuesday, 2 April 2024 at 6:30 pm ("Meeting"). The agenda in question pertains to matters concerning the lease and operation of the Cooper Park tennis courts under tender number SC7818 ("Tender"). As a dedicated ratepayer to the Council and a passionate tennis enthusiast who frequents the Cooper Park tennis courts, I find this agenda deeply troubling.

Dear councillors and others,

I currently play, and have played over many years, at courts managed by SSMG. By-and-large they do a good job. have also played at other courts in the eastern suburbs and the experience has been poor.

However, the best social tennis I have ever played, and continue to play, is at the Friday night social at Cooper Park. This is a priceless treasure for many reasons.

The social at Cooper Park is a 100% self-sustaining community event. It is old fashioned and that helps a great deal.

Moreover, it is entirely organic. You cannot register online (and then pull out without telling anyone). Those who turn up in time get to play. In peak times some are turned away. That is how prized it is.

The social tennis at Cooper Park has been running longer than any of you have been involved in the affairs of the Council.

Quite simply, it must be stipulated in any contract with SSMG that the Friday night social tennis MUST continue in its current form and method of organisation.

I am currently a member at Heffron Park. For \$35/month I can play in up to eight social games a month and have up to 90 minutes court time each day during the day. A bargain!

At Cooper Park we pay \$20/night to play on a Friday night (\$80/month for four games). So, if SSMG cannot make the social tennis on Friday night stick, entirely in its current form, it should not be awarded the contract.

If the Council is as competent as we hope, the Friday night social tennis arrangements will be written into the contract. SSMG should have no fear of this and if they do, then I suspect they are not being truthful about their plans and should not be awarded the contract. There is nothing complicated about this, so please act on it.
