

Reasons for Decision

The application has been assessed within the framework of the matters for consideration under section 4.15 of the Environmental Planning and Assessment Act 1979 and is recommended for refusal because:

- It is considered to be unsatisfactory with planning provisions contained in WLEP 2014;
- The site is not suitable for the proposed development; and
- The proposal is not in the public interest.

THAT Council, as the consent authority, refuse development consent to Development Application No. 165/2023/1 for subdivision of Lot 1 DP 270253 and then consolidation of Lot Pt 1 DP 270253 with Lot 17 DP 270253 on land at 27 Eastbourne Road Darling Point, for the following reasons:
